- Rules:** All current NRA highpower and F-Class rules will apply.
- Eligibility:** Open to all.
- Entry Fees:** \$75.00 for all individual matches (Matches 1-3,5-7); \$45.00 for Sat individual matches (Matches 1-3); \$45.00 for Sun individual matches (Matches 5-7).
Fees include NRA registration (\$9 per competitor).
- Entries:** **Register online at www.cihprs.org**
You may pay in person, cash only, in an envelope with your name, date and amount on it.
Advanced entries are suggested
Entries are limited to 60 individuals.
Cancellations prior to the commencement of firing on Sat. June 8th, 2019 will be refunded in full.
No refunds will be made after firing commences on Sat. June 8th, 2019.
- Location:** Camp Atterbury is located SE of Indiana near the town of Edinburgh, off Highway 31.
- Accommodations:** On base housing is available. Please call housing at 1-812-526-1128
Hotels are noted on the CIHPRS website www.cihprs.org
- Arrival and Role Call:** Shooters should arrive no earlier than 9am on Saturday and 8am on Sunday.
Roll Call will be at approximately 930am on Saturday and 830am on Sunday
- Category:** The only special category will be junior.
- Classification:** The NRA mid-range classification system will be used for all matches. If a competitor does not have a classification their NRA high power or Long Range classification will be used.
- Divisions:** There will be five divisions: palma rifle, any rifle, service rifle, F-Class Open, and F-Class TR. Competitors must declare division to the statistical officer before firing begins on Saturday, June 14, 2014. Change of division after this time will result in ineligibility for open or aggregate awards.
- Rifles:** Rifles are defined in rules 3.1, 3.1.1, 3.1.2, 3.1.3 for service rifles, rule 3.2 for any rifle, rule 3.3.3 for Palma rifle, and rule 3.4 for F-Class. Rule 9.1 does apply for each day, however a shooter may shoot a different rifle each day
- Sights:** Rifles defined as Rule 3.2 will use Metallic Sights Rule 3.7a for matches 1-3
Rifles defined as Rule 3.2 will use Any Sights Rule 3.7c for matches 5-7
Rifles defined as Rule 3.1 will use Any Sights Rule 3.7c for all matches
Rifles defined as Rule 3.3.3 will use Metallic Sights Rule 3.7a for all matches
Rifles defined as Rule 3.4 will use Telescopic Sights Rules 3.7b for all matches
- Scoring & Pits:** All competitors shall perform scoring duties.
- Ammunition:** Rule 3.17, provided by the competitor.
- Targets:** MR-63 and 63FC will be used at 300 yards. MR-65 and -65FC will be used at 500 yards.
MR-1 and MR-1FC will be used at 600 yards.
THIS WILL BE SHOT ON ELECTRONIC TARGETS
- Challenges:** A fee of \$2.00 will be collected in advance of each challenge.
- Additional:** The management reserves the right to refuse any entry or cause the withdrawal of any competitor who endangers or interferes in any way with the harmony of the match. We also reserve the right to change the match program without notice if deemed advisable. Competitors and spectators assume all risk of accident and loss of property.

Course of Fire: .

Saturday, June 8th, 2019 10:00 A.M.

Match 1: 300 yd. **Any Rifle / Iron Sight**, and **F-Class**, unlimited sighting shots and 20 shots for record fired in a block time of 25 minutes

Match 2: 500 yd. Prone **Any Rifle / Iron Sight**, and **F-Class**, two sighting shots and 20 shots for record fired in a block time of 25 minutes

Match 3: 600 yd. Prone **Any Rifle / Iron Sight**, and **F-Class**, two sighting shots and 20 shots for record fired in a block time of 25 minutes

Match 4: Day 1 aggregate of Matches 1-3

Sunday, June 9th, 2019 9:00 A.M.

Match 5: 300 yd. **Any Rifle / Any Sight**, and **F-Class**, unlimited sighting shots and 20 shots for record fired in a block time of 25 minutes

Match 6: 500 yd. Prone **Any Rifle / Any Sight**, and **F-Class**, two sighting shots and 20 shots for record fired in a block time of 25 minutes

Match 7: 600 yd. Prone **Any Rifle / Any Sight**, and **F-Class**, two sighting shots and 20 shots for record fired in a block time of 25 minutes

Match 8: Day 2 aggregate of Matches 5-7

Match 9: Aggregate of scores fired in Matches 4 and 8.

Awards:

Individual NRA Class awards:

There must be five or more entries in a class for one place award and the awarding of the NRA High Class regional award. Additional NRA place awards will be given for every additional 5 shooters in a class. Classes that do not have 5 competitors will be combined upwards to meet the minimum of 5 shooters. These awards are superseded by the Regional Championship NRA awards.

Regional Championship NRA Awards: Match 9 (both prone and F-class)

Winner: NRA Regional Gold Medallion

2nd Place: NRA Regional Silver Medallion

3rd Place: NRA Regional Bronze Medallion

Regional Championship CIHRPS Category Awards:

The following Category Awards will be given: High Any, Palma, Service, F-Open, and F-T/R. These awards are independent of the NRA Class and Regional Awards.

CIHRPS Cash Awards: Individual cash awards will be paid out for each match winner using the following format.

Match Winner: \$10

Daily and Grand Aggregate Category Winner: \$5 (must be 3 in a category)

1st place Class: \$5 (superceded by Match Winner, must be 3 in a class)

2nd place Class: \$3 (must be 5 in a class)

3rd place Class: \$1 (must be 6 in a class)

NRA Distingfuished Rifleman Award Step: Will be given to the top 10% of each each rifle type (Target, Palma, and F-Class). Service rifles are treated as Target rifles per NRA unless shooting with iron sights both days then they will be classified as Palma rifles. There is no distinction between F-Open and F-T/R.
