Dates: April 9<sup>th</sup>, May 7<sup>th</sup>, August 13<sup>th</sup>, September 10<sup>th</sup>

Location: Camp Atterbury, Indiana

Rules: Current NRA Highpower Rifle Rules will apply

Eligibility: Open

Classification: NRA Mid-Range classification will be used. If competitors do not have a Mid-Range classification but have either a High Power and/or Long Range classification, the higher classification will be used until competitor obtains a Mid-Range classification. Competitors with no classification in any High power discipline will fire in a separate class if 5 or more compete. Otherwise unclassified competitors will be combined with the Master Class.

Divisions: Any, Palma, Service, F-Open, and F-T/R Classes

Fees: \$30.00 for CIHPRS members, \$40.00 for non-members

Entries: Pre-registration will be available via the website. Walk up registration will be conducted at the Parking lot across from range control for an extra \$10 fee starting at 8am. Match director reserves the right to modify match program at any time until firing begins.

Match Schedule:

Roll Call at 830am on the 300 yardline of Range 6, First shot down range 9am

Match 1 (Any or Iron)- 300 yds, slow fire, prone, unlimited sighters and 20 shots fired in an infiltration block time, each shooter gets 25 minutes.

Match 2 (Any or Iron)- 500 yds, slow fire, prone, 2 convertible sighters and 20 shots fired in an infiltration block time, each hooter gets 25 minutes.

Match 3 (Any or Iron)- 600 yds, slow fire, prone, 2 convertible sighters and 20 shots fired in an infiltration block time, each shooter gets 25 minutes.

Match 4- Aggregate of scores fired in Matches 1-3. To be eligible for aggregate awards and have scores turned in competitors must fire in the same division for all matches.

Rifle: NRA Rules 3.1\*, 3.1.1, 3.1.2, 3.1.3, 3.2, 3.3, and "F" Class. Any rifle that was of US or Foreign  
**\*Any rifle that was once adopted by the US or Foreign Military that is of Peep/Post, or V-Notch/Post sights and is externally in as issued condition will compete as a service rifle**

Sights: Metallic or optical sights.

Ammunition: NRA Rule 3.17 a&b, furnished by the competitor.

Target: MR-63 (63FC F-class) at 300yds, MR-65 (65FC F-Class) at 500 yds, MR1 (MR1FC F-class) at 600 yards. This match will be shot on electronic targets

Scoring: Competitors will score for other relays.

Challenges: A fee of \$1.00 will be charged in advance for each challenge.

Match Schedule:

Roll Call at 830am. Match will start at 900am.

Match 1- 600yds, slow fire, prone any sight, unlimited sighters and 20 shots fired in an infiltration block time, each shooter gets 25 minutes.

Match 2- 600 yds, slow fire, prone any sight, 2 sighters and 20 shots fired in an infiltration block time, each shooter gets 25 minutes.

Match 3- 600 yds, slow fire, prone iron sight, unlimited sighters and 20 shots fired in an infiltration block time, each shooter gets 25 minutes.

Match 4- Aggregate of scores fired in Matches 1-3. To be eligible for aggregate awards and to have scores turned in competitors must fire in the same division for all matches and with the required sights.

Rifle: NRA Rules 3.1\*, 3.1.1, 3.1.2, 3.1.3, 3.2, 3.3, and "F" Class. Rule 9.1 does not apply

**\*Any rifle that was once adopted by the US or Foreign Military that is of Peep/Post, or V-Notch/Post sights and is externally in as issued condition will compete as a service rifle**

Sights: Metallic or Any sights.

Ammunition: NRA Rule 3.17 a&b, furnished by the competitor.

Target: MR1 (MR1FC F-class) at 600 yards. This match will be shot on electronic Targets

Scoring: Competitors will score for other relays.

Challenges: A fee of \$1.00 will be charged in advance for each challenge.
